Where: Please fill in necessary information in the application form and bring it directly to the School Education division. Please bring your Hanko (seal) with you. You can get the application form from any of following places: Hoikujyo/Hoikuen(Nursery schools), Kindergartens, Municipal elementary schools, Shiyakushyo (City office) the 7th floor School Education division, City's official website.

Notes: Please keep in mind that a new application is required to apply to a junior high school adjacent to the designated school district even if a pupil has been in an elementary school next to the school district. Documents showing evidence of the newly acquired address are required if you are planning to move your residence by March 2018.

★ What: NEW! "My Number Card" Services

Details: "My Number Card" is a card with a photo of yourself. It can be used for your ID, for getting a copy of your resident's card at a convenience store, for filing tax return (e-Tax) form, for doing administrative procedures without going to the city office, and other useful functions. Please apply for your "My Number Card" and make the most of it.

Q. What kind of certificates can we retrieve using "My Number Card"?

A. Any time and in any day, you are able to retrieve the certificates such as the copy of resident's card, at any convenience store that has multi copying machine. (See the table below.)

Q. How can we apply for "My Number Card"?

A. The "My Number Card" can be applied for by mail, the internet, smartphone, or even from the instant photo booth. You can apply for it with the application form attached to your private number card, which has been sent with a notification card.











Notes: If you change your name or address after the notification card arrived, you need to come to the city office for a new notification card. It will take about a month for you to receive your "My Number Card" after your application.

★ Keep in mind the due date of Municipal Tax Payment

Please pay your city taxes on or before the due date. During the months of November and December, a prefecture-wide effort will be made to collect unpaid taxes. Non-payment of city taxes is unfair to the many taxpayers who pay their city taxes on time. Additionally, it affects the city's finances, and can have a negative effect on the city's ability to provide services. Numazu proactively takes measures to collect unpaid taxes.

Q. What happens when city taxes are not paid?

A. A late fee is assessed when your city taxes are not paid on time and you will receive a delinquent tax notice. If no payment or consultation is made with the tax department division, after the non-payment reminder is sent, legal steps may be taken to collect the taxes, even against the taxpayer's will. As shown in the following flowchart, the department first inspects all your properties and then forecloses and sells them to collect your unpaid tax.

Q. How Late Taxes Are Collected?

A. Recently, the number of cases of enforced payment has been on the rise. In particular, in an increasing number of cases, a citizen's workplace is investigated to determine the citizen's ability to pay from his or her salary, with taxes collected from the citizen's salary. Occasionally, officials may enter the person's house without permission to conduct a financial investigation.

Q. In the Event that Taxes Cannot Be Paid

A. Please contact the city hall as soon as possible if there is any reason that your city tax cannot be paid. (e.g. illness, calamity, unemployment). The city hall will create a payment plan based on your situation.

The Flowchart of Tax Delinquency Collection Process based on the Local Tax Act

- 1. Sending of tax delinquency notice- We will send the reminder in the next 20 days after the due date for tax payment has passed. A 50 Yen fee will be charged per reminder, which will be added to your account.
- 2. Investigation of delinquent taxpayer's properties- If the tax still remains unpaid event after the notice has been sent, as investigation will be conducted which includes an examination, search, and interviews with your financial institutions, workplace, life insurance companies, or customers.
- 3. Foreclosure of properties- We will seize the properties of the delinquent taxpayer that were discovered by the investigation (such as deposits and savings, salary, life insurance, account receivable, rental fee on credit or real estate, car, movable property, etc.)
- 4. *Public Auction of Foreclosed properties* The seized propertied will be converted into money by "levying" or "public sale". The money gained by the auction will be used for the unpaid tax debt (municipal tax, delinquency tax etc.).

Important! By due process of the law, the department may take enforcement action to collect unpaid tax. The law provides that the department can inspect and foreclose the property of a delinquent taxpayer without giving him/her notice in advance.

What: Test Broadcast of J-Alert

J-Alert is a nationwide automatic warning system in Japan on a state of emergency such as an earthquake, tsunami and an armed attack. The test is held as follows:

When: November 14, around 11:00 (The announcement "This is a test broadcast" which is repeated 3 times.)

Details: November is designated as the Earthquake Disaster Prevention Month. In order to minimize earthquake and tsunami damages, it is important for each citizen recognize the danger close to us. Take this opportunity to review disaster prevention measures for each household and prepare for earthquakes and tsunamis.
