~Income Tax Return~

Where: Plaza Verde (2F Citizen Gallery)

Period: Feb. 16(Fri) ~ Mar. 15(Thurs) [except weekends]

Hours: 9:00 ~ 17:00 (Reception until 16:00)

- **★**Tax returns will not be accepted at Numazu Tax Office during the above period.
- **★**Time of guidance may alter depending on the crowd condition.
- **★**The parking space will cost ¥50 per 30 minutes (only if you order a discount ticket at the venue).

Who needs to file an income tax return?

- People who own a business, gain income from real estates, or sold a land/building that exceed the total amount of income for 2017 exceeds the total amount of income deduction like basic deduction or spouse allowance.
- People who are salaried that fall into any of the following cases below:
 - 1) People whose annual salary exceed 20,000,000 yen.
 - 2) People who earned their salary from two or more places.
 - 3) People whose total amount of extra income is less than 200,000 yen.
- People who receive a public pension

X People whose amount of pension is less than 4 million yen, and miscellaneous income except pension is less than 200,000 yen don't need to file an income tax return. (They need to file a tax return for a residence tax.)

★Tax returns will not be accepted at Municipal Tax Division in City Hall during the above period.

◆ Who needs to file a residence tax return?

Those who live in Numazu City on the day of Jan. 1, 2018 and fall into any of the following cases below:

- 1) People who were sent a form from City Hall but don't have to pay income tax
- 2) People who earned taxable income during 2016 but don't have to file a final income tax return (e.g. people whose total amount of extra income is less than 200,000 yen included)
- 3) People who didn't earn taxable income in 2017 but need proof of earnings or a tax exemption certificate
- 4) People who pay the National Health Insurance and are not supported by others
- *People who have filed the final income tax return to the tax office and salaried workers who have already deducted from employment income in the year-end adjustment need not to file the return.
- *People who will file the deductions of any insurance need to file the residence tax return even if you don't need to file a tax return.

What you should bring with you when filing a tax return

- Inkan (personal seal), something that shows your bank account number.
- Documents which adds up your income and necessary expenses (e.g. certificates of taxes deducted, detailed statement of receipts and payments)
- Documents that could prove your deductions (any deduction certificates, specifications or receipt of medical expenses)
 - **★**Please bring the tax return paper or mail of "tax return notice" from tax office, or note of report from last year if you received it.
 - **★**To report the deduction of National pension payment, please bring the certificates sent by Japan Pension Service.

Changes to the deduction of medical expenses

• There is no need for submitting receipts.

From 2017's tax return, instead of submitting receipts, the attachment of "specification about deduction of medical expense" is required.

- Receipt of medical expenses needs to be stored in your home for 5 years.
- The report for tax return with the attachment or presentation of receipt of medical expenses are allowed for $2017 \sim 2019$'s tax return.
- Self-Medication tax system is established.

If you are doing certain procedures for health maintenance and improvement and disease prevention, when the cost of switch OTC nostrum you bought gets over 12,000 yen, there will be medical expense deduction paid up to 88,000 yen.

People who have been infected by the Hepatitis C virus because of specific blood products used during surgeries can qualify for the claim. The deadline to claim has been extended until January 16th, 2023.

- Vaccination for children
 - The deadline to get Measles-Rubella vaccine by public expenses is on March 31st. If you haven't been vaccinated, please do so as soon as possible.
 - For children born between April 2nd, 2011 and April 1st, 2012
- * Information about other vaccinations can be found on the 2017 City Health Guide or on the City Webpage.

- Vaccination for adults
 - O Streptococcus pneumoniae vaccination for the elderly by public expenses is due March 31st. Applicable people will receive a vaccination ticket.
 - For people turning 65, 70, 75, 80, 85, 90, 95, 100 between April 1st, 2017 and March 31st, 2018, and haven't been vaccinated by public expenses before.



- 1. Standard life saving seminar: February 18th (Sun) 9:00 am to 12:00 pm
- 2. Advanced lifesaving seminar: March 4th (Sun) 9:00 am to 5:00 pm
- 3. First-aid extension-worker seminar: March 11th (Sun) 18th (Sun) 25th (Sun) All from 9AM until 5PM (Total of 3 times)

Where: Lifesaving workstation (City Hospital)

What:

- Standard and Advanced lifesaving: Resuscitation methods using AED (Standard is for adults, Advanced includes newborns), Blood stemming
- First-aid extension-worker: Resuscitation methods, Blood stemming, and steps until an ambulance arrives.

Who:

- Standard and Advanced lifesaving: People living, working, or studying in the City, that is in middle school or older
- First-aid extension-worker: People living, working, or studying in the city, that is in high school or older. Has attended advanced lifesaving courses and is able to attend all three classes.

Capacity:

- Standard and Advanced lifesaving: About 30 people
- First-aid extension-worker: About 20 people

Cost:

- Standard and Advanced lifesaving: Free
- First-aid extension-worker: 3672 yen for textbooks
