### **★** Medical fee aid for infertility and intrauterine growth retardation

We are providing financial aid for married couples who are suffering from infertility or intrauterine growth retardation and for couples who are desiring pregnancy.

*Targeted treatment:* General infertility treatment (including artificial insemination), particular infertility treatment, and treatment for intrauterine growth retardation

Subsidy: One- half of medical fee including insured medical treatment, maximum of annually 300,000 yen per married couple

Duration for financial support: 5 years in total
