

## **☆Increased cost of water usage will begin on April 2019**

The water fees collected has been used to maintain a comfortable life and good aquatic environment. This change of water fee aims to make sewerage sustainable and also providing a better environment for the future. Though it will be a burden, please understand the changes made.

## The content of the change of water fee

By April of 2019, the fee for the water usage is as follows:

# ★ Pension for Special Child Rearing Allowance, Children's Disability Welfare Allowance, and Special Disability Welfare Allowance

Who: People who are involved in following cases can receive an allowance Details:

- Special Child Support Allowance could be received by parents, or people who are raising children (rearer) instead of parents. The children are younger than 20 years old and has a severe or moderate physical or mental handicap.
- Welfare Allowance for Disabled children is the allowance given to children younger than 20 and are living in their houses. The child has a high priority handicap and usually needs special care in their daily life.
- Special Disability Welfare Allowance is given to people older than 20, living in their house, who has high priority handicap and usually needs special care in their daily life

According to each case, the payment will be made the next month after it has been approved. (Foreigners are also included.) Furthermore, if the income of receiver or dependent is more than the border income set by the city, the allowance will be stopped. Please contact us for any details about requirements, etc.

# ☆Tsunami drill will be carried out in March 10<sup>th</sup> (Sunday)

In Shizuoka prefecture, we have allocated 10 days including March 11<sup>th</sup> of every year as the "Tsunami measures promotion day" as a lesson from the Great East Japan Earthquake. In Numazu city, the drill will be same as the prefectural Tsunami drill on March 10th. The drill will be held in the Tsunami drill subject area. On that day, announcements will be broadcasted to the entire city.

8:00 am - Tsunami evacuation drill notice

9:00 am - Earthquake occurs (assumption) • Electric bell sound

9:03 am - Tsunami evacuation drill, with sirens

11:00 am - Finishing drill

# ★ Be aware of the PM2.5 (fine particulate matter)

- What is a P.M 2.5? A particle less than the size of 2.5 micrometer that floats in the air, which people tends to inhale them into their lungs. (1 millimeters ÷ 1000= 1 micrometer or 0.0000984 inches)
- **During Ventilation Warning:** A ventilation warning will be announced through radio broadcast in prefecture. If someone tends to have a respiratory disease or a cardiovascular disease, be very cautious. These countermeasures must be done:
  - 1. Try not to go outside of your house as possible.
  - 2. Have less activities outdoors.

- 3. Use masks that protects from viruses, or any small particles.
- *Observation System*: In Shizuoka prefecture, there are 35 stations is measuring the particulate matter for 24 hours a day. The observation data is given freely at Shizuoka Air Pollution Overtime Monitoring System.

# ☆ Procedures when moving – Registration procedures

Report your change of address within 14 days when moving. The contents will be registered on the Basic Resident Registration Card and becomes valuable data which proves your address. We will introduce the necessary steps to take when moving. Don't forget to write the full name of apartment.

## Please help us when confirming your identity

In order to prevent false registration by another person, we check each person who comes to register the change of address (moving in or out), or family register (affiliation, marriage, divorce, adoption of child, dissolution). So please present several documents which will verify your identity at the time of registration. When a deputy submits the registration, the letter of attorney is necessary.

## **Identification documents:**

Identification card:

A photo ID card issued by the government or other public offices. Examples are:

- Driver's license
- Passport
- Individual Number Card
- Basic resident registration card (with a photo)

In case of registration for moving, two of the following are also possible:

- National Health Insurance card
- National Pension handbook
- Employee ID card
- Student ID card
- Bank savings passbook

## Please prepare these documents when you come to register the following

- Certificate of All Records (Certificate of Family Register)
- Copy of Certificate of Residence
- Seal registration certificate

Services offered:

- 3. Delivery of a copy of the family register
- People who can receive services 1 and 2 are limited to the person himself or the family members only.
- People eligible to receive the copy of the family register is limited to people that have their resident
  proof and the family register registered in the Sunzu region. For more information, please contact

## ☆ Notice of the small car tax in Heisei 31 and Non-registration of bike and small car

Small car tax is required for the people who have a small car in April 2. If the name of owner is changed or the car is been wrecked after April 2nd, there won't be monthly payback installments. For bike or small car given to somebody, disposed, or lost, the owners should process the vehicle discarding procedures during March.

#### Tax for small four-wheeler and the other vehicle

The tax will depend on the month the car got its license plate. Cars that have the first-time inspection date before March in Heisei 18 (2006) will be considered as an old car and be subject to additional taxes.

## **Environmentally friendly car tax reduction:**

If the first-time inspection date of the car is between April of Heisei 30 (2018) and March of Heisei 31 (2019) and meets the certain criteria for having environmentally friendly functions, the tax will be reduced for the payment in Heisei 30 (2018) by 25%, 50%, or 75% depending on the vehicle.
