When bringing in garbage, please separate them in the same way as you would usually put them out, and take it to the designated place by yourself. To confirm that the garbage is from within Numazu City, we will ask you to confirm your address with a driver's license, etc. We may ask you to take away any garbage that cannot be

collected on-site.

December 29 and 30 are expected to be extremely busy. We kindly ask for your cooperation in adjusting bringing-in dates etc. to help avoid congestion.

<Pre><Pre>cautions when bringing in>

- Please follow the instructions of the staff as it can be dangerous inside the centre.
- No need to puncture spray cans or gas cartridges.
- Dismantle any furniture or mattresses with springs.
- Be sure to remove the batteries to prevent fire.

<Things you cannot bring in>

- Industrial waste generated as a result of business activities
- A large amount of general business waste generated as a result of business activities.
- Construction waste, tires, waste oil etc., and something contains hazardous materials
- Home appliances (TV, fridge, freezer, washing machine, clothes dryers, air conditioner), personal computer, motorcycles, etc.

(Bringing-in fee (depending on the maximum load capacity of the vehicle you use))

Vehicles with a specified loading capacity	1,240 yen per vehicle up to a maximum load of 200kg. If the maximum load exceeds 200kg, an additional 620 yen will be charged for every 100kg.

Trash disposal/ reducing guidebook

How to dispose of plastic containers and packaging

Plastic containers and packaging refer to containers and packaging made of plastic, vinyl, polystyrene foam, or other similar materials. Plastic containers that are not sorted correctly or are dirty cannot be recycled. To avoid negative impacts during intermediate processing and recycling, please dispose of them according to the rules. For details, please refer to the city website.



<Pre><Precautions for disposal>

- Only place clean plastic containers in the designated bag. If stains cannot be removed by washing or wiping, or if you are unsure whether stains have been removed, dispose of them as burnable waste.
- Do not place plastic products other than containers, such as PP bands, Ziploc bags, or clear plastic holders.
- If water accumulates at the bottom of the designated bag, it cannot be collected. Ensure all moisture is removed before disposal.
- Do not double-bag items, as this hinders foreign object detection checks.



• Do not place any plastic items with a recycling mark; bottles, cans, PET bottles, or other foreign object inside: Only items with $\[\mathcal{T} \] \]$ mark. This especially applies to items that could cause fire, injury, or infection, such as mobile batteries, lighters, and razors.


★ International Fair in Numazu ★
